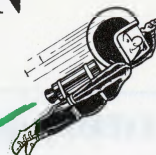

CLASS REUNION DAY, MAY 27

Saturday, May 27 has been designated Class Reunion day at the College. Members of the 50th Anniversary Class of 1917 and their wives will be the honored guests of Brother Daniel Bernian, President of the College. The Class of 1942 will be reunited also on this occasion to celebrate their 25th Anniversary.

The Classes of '22, '27, '32, '37, and '47 will be celebrating their 45th, 40th, 35th, 30th, and 20th Anniversaries respectively. Members of these classes will be hearing from their Class Committees in the near future. As last year, many faculty are expected to attend the affair.

The larger, more recent classes will continue to stage separate reunions. However, the joint reunion for the smaller classes, initiated last year, proved so successful, it was decided that the event should be continued. Groups need not be celebrating anniversaries to participate. Various classes, notably those who participated last year, are planning already to reserve tables for the affair. Cocktails will be served at 7:00 p.m. and dinner at 8:00 in the College Union Ballroom. Seating for the Dinner will be by class. Tickets are \$15 per couple (\$7.50 per person) and include the cocktail hour and dinner. Drinks will be available after the dinner.

The fifth anniversary reunion of the Class of 1962 will be held in the College Union Ballroom on the evening of Saturday, May 20. Cocktails will be served at 7:00 p.m., dinner at 8:00. Dancing after until 1:00 a.m. Tickets are priced at \$15.00 per couple and includes the cocktail hour and dinner for two. Drinks after dinner will be moderately priced. Tickets may be procured through the Alumni Office.

The Class of '63, Evening Division, will have an informal dance on Saturday evening, April 15 at 9 P. M. in the College Union Ballroom. Tickets are \$3.50 per couple and may be purchased from a member of the committee or through the Alumni Office.

THE ANNUAL FUND

John P. Ryan, '49, Chairman of the Alumni Annual Fund Committee, reports that 1,022 alumni pledged \$42,589.00 and paid \$40,551.50 to the present campaign. As of March 30, 1967, 224 of these alumni have provided inspiration and leadership by supporting the College's program as members of the Century Club.

The First Pennsylvania Banking and Trust Company has initiated a matching gift program, and has thereby joined 340 corporations who are assisting higher education in this way. Alumni employed by a matching gift company can arrange a "second" gift to their Alma Mater.

DANFORTH AND WILSON FELLOWS

Two members of the Class of '67 have won national foundation fellowships. James A. Butler, of Pittsburgh, Pa., became the first La Salle student to win both a Danforth and a Woodrow Wilson fellowship. He is an English major. Paul C. Brophy, of Philadelphia, was awarded a Woodrow Wilson fellowship. He is an Economics major.

Three other seniors received honorable mention from the Woodrow Wilson Foundation: Thomas J. Jennings, Psychology; Edward J. Quigley, Philosophy; and Brother James P. Sterba, F.S.C., Philosophy. (Further details appear in the Spring issue of *La Salle Magazine*.)

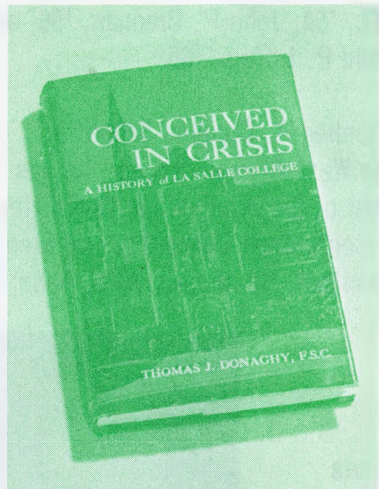

WORLD CONGRESS OF LA SALLIAN ALUMNI

Registration is \$15.00 plus \$5.00 for a wife. Costs of banquets, lodging, special tours and other information may be obtained from the Alumni Office.

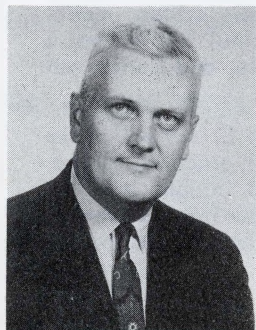
THEATRE ON CAMPUS

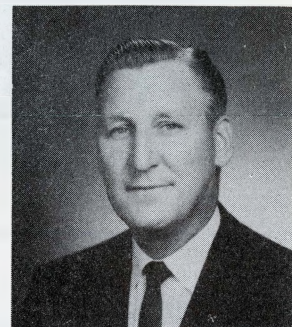

Daniel H. Kane, '49, is Principal of the Stephen A. Douglas School in Philadelphia. A founding member of the Suburban West Alumni Chapter, he has served two terms as its secretary. He is a member of the Admissions Committee (1964-67) and served on last Fall's Leadership Conference Committee. He also was chairman of last year's Signum Fidei Medal Committee.
