THE SECRET OF HAPPINESS

Lent comes upon us and then suddenly is gone. Here at the College, the mid-term exams start even before the basketball fever has had time to subside, then the Holy Week retreats begin, and then at last, the Easter holidays arrive.

That brief period for reflection wedged into a hectic college life sets a pattern that might well be carried over into alumni life, especially during Lent, a time to consider how one developed under the Brothers' guidance at La Salle, and how capably one is now handling his own interior life and his life in the world around him.

During one of these retreat periods some years ago, the saintly Brother Alfred, his white goatee bristling and his eyes shining, spoke a few words that are especially fitting at this time:

"There is an infallible way to happiness," he said, "if men will forget themselves completely and try Christ's philosophy. The rules are simple. First, we must unite our will with God's in all the events of life. If anything can render a mind serene, it is a heart wholly abandoned to God. Second, we must be of service from morning 'til night to someone, somewhere.

What we do to others reflects the condition of our own minds. A little word can make a whole day bright for another. Even on the Cross, Christ thought only of those around Him.

Third, we must strive constantly for perfection through self-discipline. The true learning of a man is known by his patience. Perfection comes slowly and with much effort, but the effort alone helps make us happier. To root out any imperfection, such as sarcasm for example, remember that multiplied victories over sarcasm bring sweetness of speech and calmness of heart.

"This philosophy of love," said Brother Alfred, "makes us happy, makes others happier, and helps keep us healthy and the master of our emotions. To make every day in this year and every year a *happy* day, say each night and morning this pleasing and appealing aspiration: 'My God I love you because you are so infinitely good and merciful.' Apart from its great spiritual value, it helps to brighten and cheer our day and its work, and prepares us for a peaceful night's repose. The love of God holds the secret of gladdening the heart even in the midst of great sorrows and crushing anguish. Do all the good you can for everybody you can, and as long as you can."
