Subject: Proper Dress

Dr. Joseph C. Reino, Assistant Professor of English, will conduct a course entitled MODERN POETRY for WFIL-TV's University of the Air. The program will be seen every Tuesday at 6:30 a.m. and 11:15 a.m.

The course in MODERN POETRY will consist of brief discussions and readings of the principal poems of the modern age, chiefly, though not exclusively, American. The program will try to emphasize that modern poetry is not at all difficult to understand, that many poets have important comments to make upon the contemporary scene (sometimes serious, sometimes amusing), and that poetry in general is an enjoyable and worthwhile experience. The course is intended for an adult audience.

SCIENCE BUILDING PROGRESS

Motion Study, a college-level text by Herbert C. Sampster, an industry lecturer at La Salle, will be published in a German language edition by the Society for Time and Motion Study of West Germany.

The text has been used at Yale University and several other American universities and colleges since 1941, when the American edition was published by the Pitman Publishing Company.

Re: Danforth, Woodrow Wilson, Rhodes, Fulbright and similar Fellowships

Because several foundations that offer fellowships for graduate study require nominees to be officially designated by the College, the following procedures are being initiated at this time.

A Fellowship Committee has been established to make selections of nominees for those foundations which require that the nominee be the official representative of the College. At present the Danforth, Rhodes, and Fulbright Fellowships require this.

The Fellowship Committee will have three voting members: the Dean of Arts and Sciences, Brother G. Robert; and two faculty men. The Director of the Counseling Center will be a non-voting member and will serve as Secretary to the Committee.

Any faculty member who nominates a student for one of these fellowships may participate in the Fellowship Committee deliberations; however, he will not have a vote. The Committee Secretary will notify such faculty members in advance about the meeting date, time, and place. The faculty member may present his nominee's case personally or in writing if he chooses. Neither is required, but one or the other would help the Committee to make appropriate selections.

A faculty member may nominate as many students for these awards as he wants. The minimum qualifications for the nomination, however, are that the student must be on the Dean's List and that the faculty man consider him an outstanding person.

The nomination procedure is a simple one. All that is necessary is that the student's name be given to the Director of the Counseling Center with an indication as to the fellowship(s) for which he is being nominated. A form for doing this is attached, but a phone call to extension 232 will do just as well.

In a recent memorandum to the faculty it was indicated that a student could be nominated for a Woodrow Wilson Fellowship by having the faculty member send the student's name, address, and college directly to Professor John A. Lester at Haverford. This is perfectly appropriate procedure; however, it has been pointed out that this might result in several different professors nominating the same student. While there is nothing wrong with that so far as the Foundation is concerned, for anyone who wants the Director of the Counseling Center will accept the

names of Woodrow Wilson nominees and send them on to Professor Lester, thus reducing duplication of effort.

The Fellowship Committee will meet prior to October 31st to consider Fulbright and Rhodes nominees. While the deadline for Danforth nominees is December 1st, the Committee would like to select those candidates at the October meeting. Hence early nominations would be appreciated.
