Subject: Additional Security Personnel to Begin This Week

I am pleased to announce that the University will provide additional security services, through a contract with Allied-Barton Security, to begin on Wednesday, March 16. Allied-Barton currently provides similar services to many educational institutions, including the University of Pennsylvania, Drexel University, and Temple University.

New security officers will patrol nearby streets primarily on police-style bicycles, and occasionally on foot, carrying La Salle radios. They will supplement La Salle's own Security and Safety Department and will bring an extra measure of security to students, faculty, and staff in proximate off-campus areas. They will give special attention to the Olney Avenue corridor from Ogontz Avenue to Church Lane, as well as local side streets.

As is the case with La Salle's own officers, Allied-Barton security personnel are not armed. They will wear gold and blue windbreaker-style jackets with blue cargo-style bicycle pants and carry La Salle photo identification cards.

This supplemental service will continue for the remainder of the spring semester and become operational for subsequent academic years.

Allied-Barton Security Services, based in King of Prussia, Pa., is one of the largest security firms in the United States, serving more than 2,100 clients in 37 states. We believe that their experience with universities will prove particularly beneficial.

ST. BASIL COURT

At La Salle, the naming of residence buildings has a meaningful history. The honor of selecting a name belongs to the University President, and tradition dictates that the name is that of a Catholic saint who is also a Doctor of the Church. Such is the case with all La Salle residences, from Saint Albert to Saint Teresa. How fitting it is that an institution of higher education recognizes these ecclesiastical writers because of their contribution to Church doctrine. In this case, President Brother Michael McGinniss' selection of Saint Basil the Great (329-379) not only meets the historical criteria but also breaks new ground by reaching out to the Eastern Church. Further, Saint Basil shares characteristics with Saint John Baptist de la Salle: austerity and piety, along with a marked interest in the poor and afflicted, as well as a belief in high standards. Also, most appropriately, the land known as South Campus was the home of Saint Basil's Orphanage, operated by the Sisters of Saint Basil the Great, until its purchase by La Salle in 1989.

Since 1961, a generous award from the Christian R. and Mary F. Lindback Foundation has enabled La Salle to recognize excellence in teaching by members of its full-time faculty. The award is presented to a faculty member whose teaching is characterized by superior knowledge of the subject matter, vitality and inspiration in its presentation in class, and devotion to helping students realize their potential.

Nominations for the award are invited from members of the full-time faculty and students in all divisions and programs of the University. The final selection from those nominations is made by a committee composed of the Provost; the Deans of Arts and Sciences, Business, and Nursing; the President of the Faculty Senate; and the Vice President for Academic Affairs of the Students' Government Association. The award is presented at the annual Commencement Ceremonies in May.

This announcement has been e-mailed to all faculty members in the past few days, along with a list of eligible faculty members and a nominating ballot. This ballot can be completed, printed, signed, and then sent to Dr. Elizabeth Paulin (Campus Box 316).

A printed version of the ballot and eligibility list is available in the Provost's Office (Administration 315), in the Continuing Studies Office (Benilde Hall, 1st floor), in the Office of the Dean of the School of Business Administration (College Hall 211) in the Office of the Dean of the School of Nursing (Wister Mezzanine), and at the Bucks County Center.

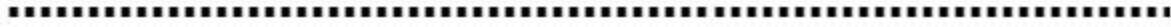

Attention: Smoking at Entrances of Buildings.



The Health Advisory Committee has received some complaints regarding individuals smoking at the entrances of buildings on campus, which results in those entering the building being exposed to second hand smoke. Please be advised that smoke can cause serious health problems for some people.

The Environmental Protection Agency calls secondhand smoke "a known human carcinogen that poses a serious public health threat." Smoke can trigger asthma attacks, serious allergy reactions and migraines.

We respectfully ask that when smoking, please do not block entrances which results in those entering the building to walk through a cloud of smoke. A fair distance would be 25 feet from entrances. We will be working with Physical Facilities and requesting that ash cans be placed away from the building entrances.

Critical Thinking Instructor (Summer, ADP)

The Critical Thinking Instructor teaches two sections of pre-freshmen, guiding these students through a series of readings and assisting them in their analysis of these readings. This is a part-time appointment for the period beginning June 21 and ending August 3, 2005.

The responsibilities of the Critical Thinking Instructor include the following:

1. Preparing a syllabus and lesson plans for two sections of a team-taught course entitled English 100, designed to prepare incoming students from the Philadelphia high schools for the academic challenges of a Lasallian education;
2. working with a Writing instructor to prepare lesson plans based on common readings;
3. assisting the students in analyzing and discussing a series of readings;
4. teaching approximately 40 pre-freshmen (20 in each section) four times a week in 50 minute classes and meeting with the students on a one-to-one basis for an additional seven hours a week (usually Wednesdays) beginning June 29;
5. writing brief end-of-summer reports on all students;
6. writing an end-of-summer evaluation of the program.
