Three Leaders To Be Honored At La Salle 124th Commencement

An internationally-known church historian, the president of the William Penn Foundation, and a leading philanthropist and proponent of cultural appreciation in the United States, will be honored at La Salle University's 124th Commencement at 1:00 P.M. on Sunday, May 17, at Philadelphia's Civic Center-Convention Hall.

Jaroslav Pelikan, Sterling Professor of History at Yale University; Bernard C. Watson, the chief executive officer of the William Penn Foundation, and Lenore Annenberg, the wife of the former ambassador to the Court of St. James who has devoted most of her life to the enhancement of the fine arts, all will receive honorary doctor of humane letters degrees.

Dr. Pelikan will be sponsored by Leo D. Rudnytzky, Ph.D., professor of German and Slavic Languages at La Salle. Dr. Watson's sponsor will be Fred J. Foley, Jr., Ph.D., vice president for development at La Salle, while Mrs. Annenberg will be sponsored by William J. Henrich, Jr., Esq., a member of the university's Board of Trustees.

Brother President Patrick Ellis, F.S.C., Ph.D., will confer bachelor's degrees on 672 men and women including 210 Evening Division students. Another 138 men and women will receive master's degrees in business administration; 24 will

be awarded master's degrees in religious education; 22 will earn master's degrees in pastoral counseling; 18 will receive master's degrees in bilingual/bicultural studies (Spanish); and 14 others will receive master's degrees in education.

Dr. Pelikan, who has written a number of internationally-acclaimed scholarly works on all areas of Christianity, is the author of the 1985 best-seller, *Jesus through the Centuries*. He has served as President Reagan's cultural ambassador to various international conferences.

Dr. Pelikan is the former president of American Society of Church History and International Congress of Luther Research and the former vice president of American Academy of Arts and Sciences.

Dr. Watson has been a teacher, counselor, and principal in the public schools of Indiana, deputy superintendent of the School District of Philadelphia, and a professor and academic vice president at Temple University. He is the author of the book, *In Spite of the System*, as well as a number of monographs and articles.

Dr. Watson is senior vice chairman of the Board of the National Urban League and a member of the executive committee of the Board of the

National Urban Coalition. He has served on a number of national educational advisory councils at the request of Presidents Johnson and Carter.

Mrs. Annenberg has been intimately involved in the operations of The Annenberg Fund, Inc., a private charitable foundation, and The Annenberg School of Communications, which were founded by her husband, Walter H. Annenberg. She was appointed Chief of Protocol of the United States in 1981 and is chairman of Friends of Art and Preservation in Embassies, a private, non-profit, non-partisan foundation established to assist the U.S. Department of State in the exhibition and preservation of fine and decorative art and furniture in U.S. Embassies, chanceries, and ambassadorial residences.

La Salle's annual U.S. Army Reserve Officers Training Corps (ROTC) commissioning ceremonies for 15 new officers will be held at 10:00 A.M. on Saturday (May 16) in the Dunleavy Room, third floor, La Salle Union on the campus at 20th st. and Olney ave.

La Salle To Offer Graduate Programs In Nursing

La Salle University will offer a Master of Science in Nursing degree beginning in September. Courses in the Graduate Nursing Programs will be offered in late afternoons, evenings, and weekends on La Salle's main campus.

Two Advanced Nurse Generalist tracks will be offered beginning in the fall—a clinician track in Adult Health and Illness and role development track in Nursing Management Administration. A clinician track in Community Health will be available in September, 1988.

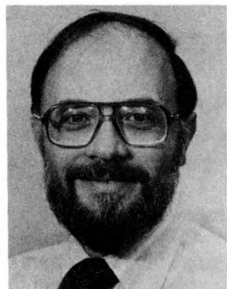

Capers, Cynthia F., RN, Ph.D., assistant professor of nursing, presented research at a nursing theory conference in Toronto, Canada in August, 1986.

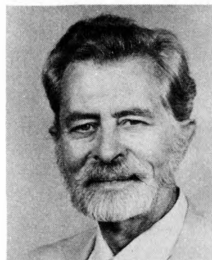
Clabaugh, Gary K., Ed.D., director of graduate education, did the following during November, 1986: he spoke on "The Holocaust: What was

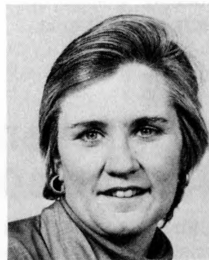
