Because of the Wister Hall construction and the resulting closure of the lower level driveway entrance there is a serious traffic problem at the upper level entrance. In order to alleviate this problem, all traffic entering main campus should use the South campus entrance on Lindley Avenue. Exceptions: truck deliveries to Campus Store and the Christian Brothers residence. This revised traffic pattern will begin on Saturday, July 18th, 1992 and remain in effect until the completion of the Wister Hall construction-sometime in mid-August.

With mixed emotions, this is to inform you that Joan Broderick recently accepted an attractive new career opportunity as the Director of Player Development for the U.S. Field Hockey Association and a search for a new Director of Academic Support Services for Student-Athletes has begun. Announcements of the vacancy are being distributed widely and advertisements will appear soon in the NCAA News, the major periodical for notices of such positions. We intend to attract a pool of well qualified candidates and, in behalf of the search committee, your help with the process is invited.

An excerpt from the announcement follows. If you are interested in being considered as a candidate or know any well-qualified individuals, please encourage them to apply or to contact me to discuss the position in greater detail. Thank you for your assistance.

... The Director will supervise a comprehensive academic support program for the 350 student-athletes who compete on 22 teams at the NCAA Division I level. The Director will provide academic advising and counseling services and assist with academic and personal skills development; serve as a liaison between faculty, administration and Athletic Department coaches and staff; monitor and maintain student academic progress records; administer and collaborate with other staff to offer tutorial, career development, and related assistance programs; and, perform other duties necessary to assist each student-athlete fulfill her/his academic and athletic potential.

Qualifications required include: a master's degree in a relevant field; considerable experience in education including teaching, coaching, and counseling/advising work, ideally with university-level student-athletes, knowledge of pertinent NCAA regulations; and, excellent inter-personal relations and oral/written communications skills.

The review of candidates will begin August 17, 1992 and continue until a successful candidate is selected for appointment early in the Fall Semester, 1992.
